## Important Notice for Revaluation Forms (November 2024 ESE Exam.)

It is notified that the students of SY B.Tech / M.Tech-II should submit the Revaluation Form and fees for Nov-2024 ESE Examination by online mode on or before 04-01-2025. The print out of **Revaluation form and payment receipt** must be submitted (<u>Back-to-Back printout</u>) personally (By Hand) to the <u>College Office</u> (Mrs. Nisha Dere) between 10.00 am to 4.00 pm on or <u>before 06-01-2025</u>.

## Instructions for the students:

- 1. The students are advised to read carefully the rules of revaluation of answer books.
- 2. The application received after the last date, for any reason, will not be considered.
- 3. Fee for Revaluation per head of passing in theory subject is Rs.400/-. If Grade is change in any course/s, fees paid for that course/s will be refunded to the <u>same account from which revaluation</u> fees are paid.
- 4. Incomplete forms will not be entertained and no correspondence will be made in that behalf.
- 5. Candidate can apply for Revaluation of Answer Book(s), for maximum 3 course/s.
- 6. Candidate should not submit double form for the same examination.

## Process for filling online examination form is as follows

- 1. Login on the portal <a href="https://vplearner.edupluscampus.com/">https://vplearner.edupluscampus.com/</a> with your Institute Enrollment Number as user ID.
- 2. Complete your profile on the portal. Verify the Bank account details mentioned in the profile.
- 3. Verify and submit the Revaluation form as Home--> Examination-->Apply for Revaluation
- 4. Pay the Revaluation fees online as applicable for you (Rs. 400/- per course.) Save the Transaction receipt.
- 5. Fill the fees transaction details correctly in the form and submit the form.
- 6. Take a Back to Back printout of the form. Submit the Revaluation form to the college Office before the deadline.

The process of the Revaluation Form is complete only after submission of Form at College Office. If the student fails to submit the Revaluation Form in the College Office within the given time, his/her form will not be processed & he/she will be solely responsible for the academic loss, if any.
